



4 JONATHAN R. HASSLER,

5 defendant herein, on or about and between May 25, 2005, and July
6 28, 2005, in Modoc County, State and Eastern District of
7 California, did knowingly possess one or more matters, to wit: a
8 Dell 5150 Laptop, serial number CN-QW0940-12961-43M-7794, which
9 contained visual depictions of minors engaged in sexually
10 explicit conduct, which were produced using materials which had
11 been mailed, shipped, and transported in interstate and foreign
12 commerce, and which visual depictions were transported and
13 shipped in interstate and foreign commerce, and the production of
14 which visual depictions involved the use of minors engaged in
15 sexually explicit conduct as defined in Title 18, United States
16 Code, Section 2256, all in violation of Title 18, United States
17 Code, Section 2252(a)(4)(B).

18 Forfeiture Allegations

19 The Grand Jury further alleges: T H A T

20 JONATHAN R. HASSLER,

21 defendant herein, upon conviction for violating 18 U.S.C. §
22 2252(a)(2), as alleged in Counts One and Two above, or for
23 violating 18 U.S.C. § 2252(a)(4)(B), as alleged in Count Three
24 above, shall forfeit to the United States his interest in any and
25 all matter which contains visual depictions produced,
26 transported, shipped or received in violation thereof; any
27 property constituting or traceable to gross profits or other

2 result of the said violations; and any and all property used or
3 intended to be used in any manner or part to commit and to
4 promote the commission of the aforementioned violations,

COUNTS ONE:

VIOLATION: 18 U.S.C. § 2252(a)(2) - Receiving and Distributing Material Involving the Sexual Exploitation of Minors

PENALTY: Imprisonment of not less than 5 years and not more than 20 years
Not more than \$250,000 fine;
Lifetime supervised release.

COUNTS TWO:

VIOLATION: 18 U.S.C. § 2252(a)(2) - Receiving and Distributing Material Involving the Sexual Exploitation of Minors

PENALTY: Imprisonment of not less than 5 years and not more than 20 years
Not more than \$250,000 fine;
Lifetime supervised release.

COUNT THREE:

VIOLATION: 18 U.S.C. § 2252(a)(4)(B) - Possession of One or More Matters Containing Depictions of Minors Engaged In Sexually Explicit Conduct

PENALTY: Imprisonment of not more than 10 years,
Not more than \$250,000 fine, or both;
Lifetime supervised release.

FORFEITURE ALLEGATION:

PENALTY As directed by Indictment

ASSESSMENT: Mandatory \$100 special assessment each count.
